PARISH COUNCIL MEETING

held on Tuesday 6th June 2017
at the Village Hall, High St.

Present: Councillors RW Johnson (Vice Chairman chaired the meeting), D Batty, G Kirt, D Lane, RW Randall, P Skinner, ETE Spendelow, D Wragg & Mr JV Haste (Clerk). There were 3 members of the public also in attendance.

MINUTES OF MEETING

Action

- 1 **APOLOGIES FOR ABSENCE** — Councillor Holdich (Chairman) not in Peterborough and councillor Mrs Bysshe prior commitment
- 2 **MEMBERS DECLARATIONS OF INTEREST** – None declared
- 3 **PUBLIC PARTICIPATION** –
 - David Cowcill referred to the matter on the agenda and was of the opinion that the main issue for the village was traffic congestion and parking. David noted that consideration of the city council Local Plan inevitably looked at the pros and cons of development, however sub optimal patchwork development would add to the traffic problem and called for a traffic generation analysis for any future development. Councillor Kirt responded that a major factor in the traffic problems was that generated by AMVC and was of the opinion that a solution was impossible without an alternative access to the school site
 - Jeff Bell expressed concern at the speed of vehicles entering the village by the Peakirk Road and noted the 20 mph did not start until the bend near the local shop. He asked for consideration be given to extending the 20 mph limit further down to Peakirk Road. Cllr Johnson in reply was of the opinion that the distance from a school determined how far such a limit could be extended
- 4 **PLANNING**

The sole agenda item was consideration of the “Key Issues” document produced by the city council. That document summarizes 2014 comments on the draft local plan received from 1056 individuals and organisations.

The clerk reminded us of the process whereby

- a “Call for sites” had generated a number of potential sites being suggested by developers and landowners.
- Parish council had commented on those suggested sites.
- Peterborough City council had produced a draft Local Plan classifying Glington as a medium sized village and not including any developments other than those already committed.
- That draft Local plan had generated the comments summarised in the “Key Issues” document.

The clerk had been advised that PCC Officers would consider the observations behind the summarised “Key Issues” and produce a final draft document in the autumn of this year.

Parish Council were disappointed not to be able to comment on the observations of developers and Landowners.

Parish council considered in detail the observations relevant to Glington and noted that in the main they came from developers and Landowners. Those comments were to be expected given that those developers and landowners had put forward many sites not included in the latest draft. It was also noted that there was considerable opposition to the proposed large scale development in Ailsworth and that the opponents of that development were supporting the suggestion of spreading developments around the rural communities.

Parish council noted that some of the observations behind the “Key issues” were at odds with the results of the survey which formed the basis of the Glington Neighbourhood plan currently

being prepared.

In concluding consideration of this item members

RESOLVED to “resist any unwanted development proposal not in keeping with the emerging neighbourhood plan”

Proposed Cllr. Johnson Seconded Cllr. Randall

Members also considered setting up a working group to consider the implications of all the local plan responses affecting Glington, but deferred a decision to the next meeting given that the chairman and Cllr Bysse were absent and may have a view. Cllr Kirt gave his apologies for the next meeting but indicated a willingness to be included if such a working group was agreed.
